

The Uttarakhand quota is 50% of the seats and All India quota is 35% of the approved intake. 15% seats are in the Management quota. Admission against the Management Quota seats, in each programme will be done in the Institute strictly on the basis of merit drawn from amongst those who get themselves registered with the Institute.
